



# SELF-EMPLOYMENT INCOME SUPPORT-SCHEME

On 26 March 2020, the government announced the introduction of the Self-employment Income Support Scheme (SEISS). This scheme is to provide financial help to self-employed individuals, including members of a partnership, who have lost income due to Covid-19.

This is welcome news for the self-employed and the key details released so far are as follows:

#### How much will you get?

You can claim a grant of 80% of your average trading profits over the last 3 years, up to a maximum of £2,500 per month for the next 3 months (1 March 2020 until 31 May 2020). The government pledges that the scheme may be extended if needed.

### **Eligibility Criteria**

- Your self-employment trading profits <u>must be</u> <u>less</u> than £50,000 and, more than 50% of your total income must come from self-employment. This is determined by at least one of the following conditions being met:
  - Trading profits in the tax year ended 5 April 2019 of less than £50,000 and these profits are more than 50% of your total taxable income; or
  - Your average annual trading profit for the last 3 tax years up to the year ended 5 April 2019 is less than £50,000 and must be more than 50% of your average taxable income over the same period.
- You must have submitted your Tax Return for the year ended 5 April 2019 which was due for filing by 31 January 2020.
- 3. You must have traded during the 2019/20 tax year.

- You must be trading at the time of making the application or would be except for COVID-19.
- 5. You intend on continuing to trade in the next tax year (2020/21).
- 6. You have lost self-employment or partnership trading profits as a result of COVID-19.

#### How to Apply

HMRC will use the information from your submitted 2018/19 Tax Return to identify if you are eligible for the scheme. If you are eligible, HMRC will contact you and invite you to apply online.

## How and When You Will Receive the Grant

Once your application is processed by HMRC they will inform you how much you will get. The grant will be paid directly into your bank in one lump sum. Payment is expected in early June 2020.
